To help ensure a rewarding experience for our clients, we provide you with this Privacy Policy that describes our privacy practices, including how we collect, use and disclose personal information.

- 1. We directly collect, use and disclose your personal information, including information obtained in the past and information obtained in the future, for the purposes of:
 - processing applications for Loans and any new applications for loan and credit products;
 - providing information to suppliers of products and services to our clients or RECI,
 Re-Establishing Credit Independence Inc., including data service providers, in connection with Loans or other credit products;
 - understanding our clients needs and determining the suitability of products and services for our clients, determining eligibility for these products and services for our clients; providing information about products and services and special promotions to our clients; enabling RECI, Re-Establishing Credit Independence Inc. affiliates and other carefully selected organizations to provide information about products to our clients; analyzing client's information for marketing purposes, including conducting surveys, developing and enhancing products and services, and ensuring high services standards;
